



**ENVIRONMENTAL ASSESSMENT ACT SECTION 7.1
NOTICE OF COMPLETION OF MINISTRY REVIEW**

**AN INVITATION TO COMMENT ON THE ENVIRONMENTAL ASSESSMENT
FOR THE DURHAM AND YORK RESIDUAL WASTE STUDY**

An environmental assessment (EA) has been submitted to the Ministry of the Environment by the Regional Municipalities of Durham and York for the undertaking, the construction and operation of a thermal treatment waste management facility, in the Municipality of Clarington in Durham Region. The Ministry of the Environment has prepared a Review of the EA for comment by the public, government agencies, Aboriginal communities and other interested persons. The Review of the EA does not make a decision about the EA. That decision is made by the Minister of the Environment after the comment period is over and in consideration of all submissions.

You can submit comments on the undertaking, the environmental assessment, the amendment to the EA, the addendum to section 9.2 of the EA and the ministry Review. You may also request a hearing by the Environmental Review Tribunal. If you request a hearing you must state in your submission, whether you are requesting a hearing on the whole application or on only specified matters related to the application.
